1. Field of the Invention The present invention relates to a process for the production of quasi-aromatic polymers and to quasi-aromatic polymers produced by the process. 2. Background Art Quasi-aromatic polymers have excellent properties (such as thermal resistance and chemical resistance) and, therefore, are useful for use in various applications (for example, in the fields of high-performance resin moldings and top-coatings). Of these applications, use is extensively made of cases of using the quasi-aromatic polymers for the top-coating, particularly, as a top-coat for resins of an electric device and an electronic device (for example, for an external component of an electric device and a power supply such as a battery). The electric device is becoming increasingly lighter, thinner, and miniaturized. In particular, an increase in performance of batteries has been increasing in recent years. Accordingly, a demand for high electric conductivity and corrosion resistance has been increasing in top-coat materials for such batteries. An example of a process for producing a quasi-aromatic polymer which is used for the top-coat for an electric device and an electronic device has been known from Japanese Patent Application Laid-Open (kokai) Nos. 50-219147, 60-90466, 62-255943, and 62-255944. Of the processes, the process in which the aromatic group-containing monomer having a ring-opening reactivity is polymerized in the presence of an inorganic ionic species and, thereby, a quasi-aromatic polymer is obtained is advantageous in that reaction conditions are mild. However, the process has a problem that a catalyst is present in the polymerization system and, therefore, the purity of the produced polymer is low. It has been reported that an amorphous polymer can be prepared by a catalyst-free polymerization process using a monomer having a ring-opening reactivity and having an aromatic group (for example, refer to D. Thompson et al., *Macromolecules*, 28, 7991, 1995). It has been also reported that an amorphous polymer can be produced by adding a polymerization initiator to a mixed solution of a monomer having a ring-opening reactivity and a polymerization initiator, while excluding water from the mixed solution (for example, refer to Japanese Patent Application Laid-Open (kokai) Nos. 3-150845 and 11-27
